# read first! Important Safety Precautions!

11. Grounding or Polarization. This product may be equipped with a polarized alternating-current line plug (a plug having one blade wider than the other). This plug will fit into the power outlet only one way. This is a safety feature. If you are unable to insert the plug fully into the outlet, try reversing the plug. If the plug should still fail to fit, contact your electrician to replace your obsolete outlet. Do not defeat the safety purpose of the polarized plug. 12. Power-Cord Protection. Powersupply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, paying particular attention to cords at plugs, convenience receptacles, and the point where they exit from the product.

13. Cleaning. Unplug this product from the wall outlet before cleaning. Do not use liquid cleaners or aerosol cleaners. Use a damp cloth for cleaning.

14. Nonuse Periods. The power cord of the product should be unplugged from the outlet when left unused for long periods of time.

15. Lightning. For added protection for this product during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the product due to lightning and power-line surges. 16. Overloading. Do not overload wall outlets, extension cords, or integral convenience receptacles, as this can result in a risk of fire or electric shock.

17. Object and Liquid Entry. Never push objects of any kind into this product through openings, as they may touch dangerous voltage points or short-out parts that could result in a fire or electric shock. Never spill liquid of any kind on the product.

#### 18. Damage Requiring Service.

# **two.** Speaker Connections


#### **Connection Tips**



For satellites, thread speaker wire through the hole in the bottom of the speaker, then feed it through the recessed wire channel.




Separate and strip the ends of the speaker wire as shown. Speakers and electronics terminals have corresponding (+) and (-) terminals. It is important to connect both speakers identically: (+) on the speaker to (+) on the amplifier and (-) on the speaker to (-) on the amplifier. Wiring "out of phase" results in thin sound, weak bass and a poor stereo image.

#### Line level





Note: Some receivers/ amplifiers have a single (mono) subwoofer output. In this case, it is recommended that you use a "Y"-connector (not included) to maximize the subwoofer's performance.

#### Troubleshooting

#### If there is no sound from any of the speakers, check the following:

• Receiver/amplifier is on and

a source is playing.

• Powered subwoofer is plugged in and is either in the "On" or "Auto" position.

 Check all wires and connections between receiver/ amplifier and speakers. Make sure all wires are connected.
 Make sure none of the speaker wires are frayed, cut, or punctured.

• Review proper operation of your receiver/amplifier.

# If there is no sound coming from one speaker, check the following:

• Check the "Balance" control on your receiver/amplifier.

• Check all wires and connections between receiver/ amplifier and speakers. Make sure all wires are connected.

# If the system plays at low volumes but shuts off as volume is increased, check the following:

• Check all wires and connections between receiver/ amplifier and speakers. Make sure all wires are connected. Make sure none of the speaker wires are frayed, cut, or punctured.

• If more than one pair of main speakers is being used, check the minimum impedance requirements of your receiver/amplifier.

## If there is low bass output, check the following:

• Make sure the connections to the left and right "Speaker Inputs" have the correct polarity (+ and -). • Make sure that the subwoofer is plugged into an active electrical outlet.

• Powered subwoofer is plugged in and is either in the "On" or "Auto" position.

#### If there is no sound from the surround speakers, check the following:

 Check all wires and connections between receiver/ amplifier and speakers. Make sure all wires are connected.
 Make sure none of the speaker wires are frayed, cut, or punctured.

• Review proper operation of your receiver/amplifier and its surround sound features.

• Make sure the movie or TV show, you are watching is recorded in Dolby surround. If it is not, check to see if your receiver/amplifier has other surround modes you may use.
